DETACH ALONG THIS LINE

(Fold along this line)

The law requires you to have this Notice in addition to your Registration Certificate, in your personal possession at all times and to surrender it upon entering active duty in the Armed Forces.

The law requires you to notify your local board in writing within 30 days after it occurs, (1) of every change in your address, physical condition and occupational (including student), marital, family, dependency and military status, and (2) of any other fact which might change your classification.

Any person who alters, forges, knowingly destroys, knowingly mutilates or in any manner changes this certificate or who, for the purpose of false identification or representation, has in his possession a certificate of another or who delivers his certificate to another to be used for such purpose, may be fined not to exceed \$10,000 or imprisoned for not more than 5 years, or both.

Vietnam & PTSD

Vietnam War

- 1975 Fall of Saigon
- 1988 1st epidemiologic studies of PTSD in VN veterans begin
- 2007-13 2nd wave of epidemiologic studies of PTSD in VN veterans
 - *VA CSP 569 A Twin Study of the Course & Consequences of PTSD in Vietnam Era Veterans*
 - *VA CSP 579 Determining the Physical & Mental Health Status of Women Vietnam Veterans*

Post-traumatic Stress Disorder

- 1980 DSM III recognizes PTSD
- 1987 DSM III-R significantly revises PTSD criteria
- 1994 DSM IV more PTSD revisions
- 2013 DSM V more PTSD revisions
- 2022 DSM V-TR more PTSD revisions

Women Serving in Vietnam

- >265,000 women served during the Vietnam Era
 - *Nurses*
 - *Intelligence analysts*
 - *Communication specialists*
- ~11,000 served in Vietnam
 - *90% were nurses*
 - *Usually served 1 year tours*
 - *All were volunteers*

Study Design

- Mail and telephone survey
 - *Structured psychiatric interview to determine current and lifetime PTSD (CIDI)*
 - *Wartime stressors*
 - *Other health problems (e.g., diabetes)*
 - *Service areas: Vietnam, near Vietnam, US*
- Used identical instruments in both studies to compare VN veteran women's and men's health
- Response
 - *4219 complete (both mail and telephone)*
 - *1045 partial*

Selected Subscales of Women's Wartime Exposure Scale (WWES)

Sexual discrimination and harassment

- How often did you feel extremely isolated by virtue of being a woman?
- How often did you encounter unfair treatment because of your gender?
- Did you encounter disturbing or threatening comments of a sexual nature?
- Did you experience unwanted sexual touching or fondling?
- Did you have a sexual experience that was unwanted and involved the use or threat of force by someone you knew?
- Did you have a sexual experience that was unwanted and involved the use or threat of force by someone you did not know?
- Did you have intimate relationships that turned out to be deceiving?

Triage or death

- How often were you involved in the post-mortem preparation and/or evacuation of bodies?
- How often did you assist someone in their request to die?
- How often did you sit with someone who was dying?
- How often did you have to decide who would receive lifesaving care?
- How often did you feel responsible for making the decision to allow someone to die?
- During the Vietnam era, how many men and women that you were close to were killed, wounded or listed as POW/MIA?

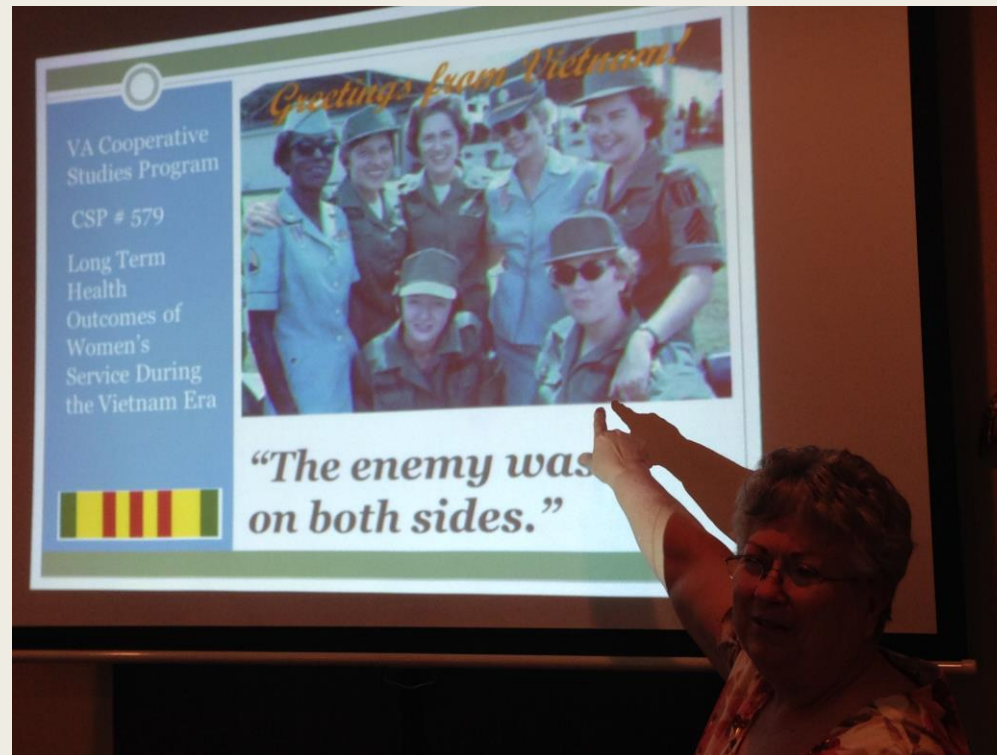

PTSD Summary

- PTSD prevalence for both women and men who served in VN was higher than for those who served elsewhere
- PTSD prevalence (current and LT) for women was higher than for males in the VN and nonVN strata
- The elevated prevalence for women veterans serving in VN was not due to pre-military PTSD
- Wartime exposure to sexual discrimination/harassment, performance pressure, and triage/death contributed to elevated prevalence for those women in VN
