



## **“Months of Chance” Promotions**

### **1. Eligibility**

To participate, you must be a current Maleno apartment community resident and 18 years or older. Void where prohibited by law. Maleno employees, subsidiaries, affiliates, suppliers, advertising and promotion agencies, and employees' immediate family members, are ineligible to participate in the contest/sweepstakes.

### **2. Sponsorship**

Maleno will conduct each promotion as described in our Official Rules.

### **3. Agreement to Rules**

By entering a Maleno-sponsored contest or sweepstakes, participants agree to abide by Maleno's Official Rules and decisions. We have the right to refuse, withdraw, or disqualify entries at our sole discretion. Participant agrees to accept the decision of the Sponsor as final and binding.

### **4. Entry Period**

The promotion period for the “Guess How Many Individual Beads” contest or sweepstakes will be between 11:00 AM on 3/17/21 and midnight on 3/23/21 when the contest ends.

### **5. How to Enter**

Multiple entries are allowed per person, by posting in the comments field in the associated contest or sweepstakes post on Facebook. Alternatively, you may take your written answer or photo to either of Maleno's property offices located at 2315

Jamestown Dr or 5355 Rome Dr, Erie, PA. Fraudulent methods of entry or circumvention of the rules may result in Maleno invalidating a participant's entries.

## **6. Prizes**

Winners will receive a prize valued at \$25.00, Prizes may be substituted at the sole discretion of Maleno. Acceptance of the prize grants Maleno permission to use the Winners entry, name, and likeness for advertising, promotion, and trade without further compensation or remuneration unless prohibited by law.

## **7. Odds**

The odds of winning are dependent upon the number of eligible entries received.

## **8. Selection and Notification of the Winner**

The winner can be selected by a random drawing or a panel of judges (if a skills-based contest.) under Maleno's supervision. Winner will be notified by phone or email within 7 days of the contests or sweepstake's end date. Winner must claim his or her prize within 30 days of notification or the prize may be forfeited if he/she doesn't contact Maleno within the time limit.

Maleno is not liable for the winner's failure to receive notification of winning if he or she provided a wrong email address or incorrect phone number or if their email security settings caused Maleno's prize notification to go into the spam or junk folder.

Receipt of the prize is upon the condition of compliance with federal, state, and local laws.

## **9. Rights Granted by the Entrant**

Participant grants to Maleno, the Sponsor, upon submission of an entry into the sweepstakes or contest the right to use the participant's submission, voice, likeness, image, statements about the contest, sweepstakes, etc., for publicity, news, advertising, promotional purposes, trade, and so forth, without any further notice, review, consent, compensation, or remuneration.

Maleno has the right to disqualify anyone who violates the terms, as well as the right to seek damages to the fullest extent permitted by law in cases where a participant has caused deliberate damage or undermined the legal operation of the promotion.
