



## Release of Liability / Agreement Not to Sue

I \_\_\_\_\_, I am aware that I am participating in a guided zip-line tour. The zip-line consists of a pulley suspended on a cable, mounted on a slope. It is designed to enable a user propelled by gravity to travel from the top to the bottom of the inclined cable by holding on to, or attaching to, the freely moving pulley. I am aware that it is a ground-to-ground course consisting of 6 zip lines, ranging in speeds of 0 to 60 mph.

I am aware that participating in the **Zip Adventures** activities includes certain risks. I fully understand and acknowledge that: (A) outdoor recreational activities such as zip lines, canopy tours, challenge courses, mountain hiking and exploring have inherent risks, dangers, and hazards and such may exist in my use of Zip Adventures of Vail's property and equipment and my participation in the above mentioned activities; (B) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, strains, fracture, partial and/or total paralysis, death or other ailments that could cause serious disability; injuries to hands, feet, ankles, head and any other parts of my body from contact with the zip line, ground, or other objects or persons during operation; injuries or death from the malfunction and/or failure of the zip-lining equipment, malfunction and/or failure of the braking system; injuries from improper or unexpected entry into the landing area; exposure to insect and snake bites, exposure to extreme temperatures and inclement weather, slips and falls, encounters with animals such as dogs, coyotes, mountain lions, and bears, collisions with other participants or objects, my physical condition, and injury and illness in remote areas without means of rapid evacuation or adequate medical care; (C) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Zip Adventures of Vail, the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. If I choose to participate in Zip Adventures of Vail guided activities, risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, misjudgment of a guide, weather, trail or course conditions, my physical or mental ability to participate in the activity, risks of falling from high platforms, stands or towers and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; and; (D) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of Zip Adventures of Vail or by any other person, and that they may arise from foreseeable or unforeseeable causes.

For reliance by Setab Entertainment, LLC d/b/a Zip Adventures of Vail ("Zip Adventures of Vail"), I state that I am voluntarily participating in this activity (with or without instruction), and that I have full knowledge of the dangers involved. I hereby accept full responsibility for the risks and dangers to me connected with any **Zip Adventures** activities. (If the participant is a minor, "I," "me," and similar words also refer to the participant's parent(s) or legal guardian(s). If the participant is a minor, "you" and similar words also include the minor even if the participant's parent(s) or legal guardian(s) are signing on the participant's behalf.)

The specific rights of the parties may vary from state to state. If any part of this release is deemed unenforceable, all other parts shall be given full force and effect.
