WHO WE ARE

Cavalier Angels (CAV Angels for short) is a non-profit investment and educational club based in Charlottesville, Virginia composed of UVA alumni, faculty, parents, students and friends of the University.

CAV Angels is formally an Alumni Interest Group of the UVA Alumni Association. CAV Angels works closely with UVA faculty including the faculty of the Darden School, the McIntire School, the Law School and the Engineering School on educational activities and opportunities for its members and for current UVA students.

OUR MISSION

1. To provide education on investment in private, early stage companies for members of the UVA family, with particular emphasis on providing opportunities to UVA students through practical experience.
2. To facilitate investment by members of the club in early stage growth companies founded by, owned by, or managed by members of the UVA family.

MEMBERSHIP

Members will have the full benefit of national membership, including access to all deal flow, connection to other members through the GUST system, and participation in activities of the Angel Capital Association. To provide opportunities for a full range of the UVA family to participate in the various activities of the club, CAV Angels has three different membership categories:

Full Members (accredited investors)

- Full access to all club activities
- Ability to invest in club deals
- Access to all social and educational activities

Educational Members (non-accredited investors)

- Cannot invest in club deals, but otherwise can participate fully in club activities
- Principally for alumni who are interested in learning about angel investing
- Integrated into the Young Alumni Council of the UVA Alumni Association's entrepreneurship activities

Student Members

- Must be a full-time student at UVA
- Must participate in a relevant student club (e.g. McIntire's Virginia Venture Fund, the Darden Entrepreneur and Venture Capital club, or the Law School's Entrepreneurial Law Society)
- Gain valuable experience by assisting club management with due diligence on potential investments
- Access to all educational and networking activities

ACTIVITIES

Educational Activities

CAV Angels provides a regular program of educational activities for its members, drawing on the resources of the Darden School, McIntire School, and Law School of the University of Virginia; the Angel Capital Association; and the professional expertise of its corporate sponsors. Strong emphasis is placed on using the offerings of the educational arms of the Angel Capital Association and the Angel Resource Institute.

Investment Activities

To satisfy the different investing needs of its members, CAV Angels offers or will offer in the future a variety of investment opportunities. These include:

- Direct investments by individual members in a specific company offering brought to members by the club.
- Investments in a club fund which will make investments in a portfolio of companies, with investment decisions being made by a majority vote of investor interests in the club.
- Direct investments in individual company offerings made through special purpose vehicles (Virginia LLCs) that aggregate individual members' investments so that one single investment in the company can be made.
- Investments in a passive tracking fund.

LOCAL CHAPTERS

Beyond the national membership, CAV Angels is organized into regional chapters that parallel and interact with the existing chapters of the UVA Alumni Association and alumni groups for the Darden School, Law School, and McIntire School. These chapters allow members to socialize and attend local events relating to angel and private equity investing.
