**Abstract of Presentation:** *Describe the proposed presentation.*

It is critical that abstracts clearly describe the topic and why it would interest convention attendees. Abstracts must be succinct as it is used as the session's description training for marketing purposes. Limit the abstract to **50 words**. All abstract descriptions are subject to editing.

**Speaker Contact Information:** *Include the following for all proposed speakers:*

Name, professional title, tribe/company/organization, mailing address, telephone number, cell phone number, and e-mail address.

**Speaker Biography:** *Submit a one-paragraph biography of each proposed speaker.* Biographies must meet a maximum of 100 words.

**Speaker Photo:** *Submit your high-resolution photo to [redwards@naihc.net](mailto:redwards@naihc.net).* Photos must meet the 300 dpi (450x600) resolution requirements.

**Session Length and Format:** *Sessions are offered in **90-minute** segments.*

NAIHC encourages panel presentations that include success stories and examples from tribal housing programs.
