Due to the high visibility of our galleries, artists should enter work that is appropriate to all audiences.

Entries must be emailed, delivered or postmarked no later than Wednesday, October 3, 2018. A notification of jury results and proposed exhibition calendar will be emailed by Monday, November 12, 2018.



GROUP SHOWS

Group shows will be considered. Please include a total of five images that illustrate the work of the group participants. A brief description of the proposed exhibit—including theme, number of exhibiting artists and their contact information—must accompany the submission. One application and jury fee per group show submission.



MidCoast staff will assist with installations, but we do not take responsibility for delivery or pick-up transit. By entering your images, you agree that your artwork images may be shared for publicity with local media, Facebook, email blasts, and posted on MidCoast Fine Arts' website. MidCoast budgets for a modest reception per exhibition: the Final Friday (last Friday of the month and mid-December) at Bucktown; the middle Friday of the month at Gallery West, and by request at Moline Centre Station. MidCoast Fine Arts does not charge a commission on sales in these galleries. If an immediate sale is necessary and MidCoast staff members are not available, the Moline Centre Station gift shop run by MetroLINK charges a 22% commission for processing the sale.
