

ENTRY CALENDAR

Entries must be emailed or postmarked no later than Saturday, January 28, 2017. A notification of jury results and proposed exhibition calendar will be emailed Monday, February 20, 2017.

GROUP SHOWS

Group shows will be considered for Gallery West and Bucktown only. Please include a total of five images that illustrate the work of group participants. A brief description of the proposed exhibit—including theme and number of exhibiting artists—must accompany the submission. One application and jury fee per group show submission.

PROMOTION

Artwork images will be shared with local media, email blasts, and posted on the MFA website.

INSURANCE

Exhibiting artists are responsible for their own insurance for lost or damaged artwork, personal effects or equipment.
