Blackstone Wins March Madness Chili Wars on Record-Setting Day

When is the Use of Force Excessive?

We all have either seen it on the news or on social media the excessive use of force by police and security professionals and the outcry from the public for lawmakers to do something about it. Community involvement, defunding the police and training on de-escalation are pressing issues that have become talking points in the news calling for something to be done to stop it. So, I bring up the questions, when does the use of force become excessive and when is it reasonable?

We all might have an opinion about this topic, or we might have a preconceived perception of what is excessive or what would be reasonable in a situation. In any circumstance I believe that we all can agree we all want to be treated as humans whether it be from our friends or family members to even casual contact with strangers.

We also would hope that law enforcement and security professionals would be held to a higher standard. So where is the line drawn from using reasonable force to excessive force? The public may see reasonable as rights, whether it be from religion, race, gender, and even constitutionally we want to be protected. But does this give us the right to not comply with law enforcement or private security?

To lay some groundwork we would need to know the definitions of reasonable force and excessive force: (Taken from Merriam-Webster)

Reasonable: Being in accordance with reason.

Reasonable force varies depending on the circumstances.
 In order to determine if the amount of force used is reasonable, the reasonable person standard is applied.
 Under this standard, actions will be considered reasonable if a reasonable person would have acted in the same way under the same (or similar) circumstances.

Excessive: Implies an amount or degree too great to be reasonable or acceptable.

• Excessive force is any force used which exceeds what is necessary to gain compliance or control.

Force: As in pressure.

• The use of power to impose one's will on another.

The use of force can only be justified if it is reasonable, and a reasonable person would agree that the degree of force is warranted.

A clearer definition would be we can only use the same force as someone is using against us. We get this standard by following the use of force continuum that lays out what force is justified:

Level 1 – Presence *Officers' presence and professional bearing. (No physical contact)

Level 2 – Verbal *Giving directives or orders.

(Clear and deliberate instructions)

Level 3 – Empty-hand control *Holds / wrist locks up to strikes to gain compliance. (Hands on control / Pressure Points)

Level 4 – Less-lethal methods *Impact weapons / Chemical sprays / Taser (Pain compliance / Strikes / Chemical agents)

Level 5 – Lethal force *Any force that's likely to cause serious bodily harm or death. (Weapons / Strikes to vital areas)

This use of force model is designed to only use the amount of force that is used against us to get voluntary compliance or gain control of a resisting subject. Of course, the presence of an officer means something, but verbal control is one of our strongest uses of force. Our verbal communication is something we must practice and relates to our appearance, our distance, our tone (how we say it) and what we say to de-escalate a situation. If it escalates past verbal and a subject touches us, officers now can be reasonable to touch the subject back and even use less-lethal methods to gain control.

More importantly, we should de-escalate as soon as compliance is gained, this is important to show that no more force was used than what was reasonable. This relates directly to us as security officers when dealing with others. Sometimes progressing our use of force is needed to gain control, but we can see that de-escalation is required to be perceived as reasonable.

Hence, the need for de-escalation techniques and training are so important to use when dealing with an out-of-control situation. AVADE certification training on de-escalation within Blackstone Security Services and officers utilizing it while on duty has been influential in recent incidents where these techniques made a difference between a safe ending or something we would be see in the news. So, in answer to the question, is the degree of force used excessive? I say to you, yes, there is always another choice than the use of physical force against someone. The presence of us as professionals and utilizing verbal control with de-escalation techniques can prevent moving to higher levels of the use of force.

Keep safe and de-escalate!



The market size of the security services industry in the United States has increased steadily since 2011, reaching a value of over 50 billion U.S. dollars in 2022. Despite the economic effects of COVID-19, the industry has continued to grow and is now worth almost five billion U.S. dollars more than it was in 2020. (Graph provided by Statista)

Quietly Disarmed Suicidal Mass Shooter

Blackstone Security Services guard Errol Bernard has been recognized as the top security guard in the nation for 2022-23 by an arm of an international organization for his effort in de-escalating a situation in July last year that prevented a mass shooting at a high-traffic retail client site in Las Vegas, Nevada.

In its first ever recognition program, the HUB Private Security Team selected the top three most incredible actions by private security guards nationwide.

Because there was no physical confrontation, Bernard's effort received no media coverage. The planned shooting never happened.

Bernard's action was all the more incredible because he did it without alarming any of the hundreds of patrons that were in the business at the time. Bernard followed his de-escalation training and his post orders and went about calming the distraught, would-be shooter and removed him from the crowded area quietly and without calling attention to what was happening to a concealed area where Bernard used verbal judo to persuade the subject to surrender his weapon. The police were called and removed the subject. This pleased the client, part of a national chain, who would not benefit from the publicity if its patrons knew there was an armed, suicidal person in their midst who wanted to harm them.

- **3. Officer Tiago De Morais of Southwest Patrol.** For engaging calmly with a distraught, suicidal man and preventing him from harming himself or others and helping to get the man transported to a hospital for care.

For his effort, Bernard will receive a "thank you" package and a handwritten letter from HUB International. 

What Sarai's opinion is as of right now about Blackstone is the same opinion I hold." So, it will be a family affair for a long time.

For his part, George said the arrangement has been a pleasant experience. "It feels good, I've never worked with family before," he explained. "I was in construction before, so this is a little easier. I'm a patrol officer so I enjoy that part of it. I don't have to dig any holes."

George recounted that when his son-in-law first approached him about a security job, he was already working and did not pay much attention. "But after I had not worked for 10 years, Frank said you've got do this dad, and I'm glad I did," George laughed. "It's better than just sitting around doing nothing. It took him a few tries; I don't know why I guess I'm just hard-headed that way."

George said his wife, Judy, was all for him working in security and expressed an interest herself, but that did not work out. George said the only difference he has with Andrew is that Andrew is a Seattle Seahawks fan, like his wife, and he is a Cardinals fan. "I like Andrew he's an intelligent young man.
