### **Suspected child predator arrested in Greeley, CO**

Steaven Henderson, 37, is accused of luring a young boy to his home and sexually assaulting him.

GREELEY, Colo. — An anonymous tip to [Northern Colorado Crime Stoppers](#) has led to the arrest of a suspected child sex predator, the [Greeley Police Department \(GPD\)](#) said Friday. GPD said in a release they received the tip on July 28 and later arrested Steaven Anthony Henderson, who they said groomed and lured a young boy to his home in Greeley and sexually assaulted him. Police said the tip suggested Henderson, 37, may have visited local parks and apartment complexes in search of young male victims in the area of 14th Avenue and 5th Street. Henderson was arrested at his home on Aug. 5, police said, on a felony charge of sexual assault on a child (pattern of abuse) and taken to the Weld County Jail.



GPD is asking anyone who was a past victim of Henderson's, believes their child may have been a victim, or has seen Henderson around children in their area to call Det. Dave Arpin at 970-350-9575.

Calls to the Northern Colorado Crime Stoppers are not recorded and the phone does not have caller ID, according to [the NoCoCrimestoppers website](https://www.nococrimestoppers.com). A coordinator completes a tips information form, makes initial inquiries and passes the information along to investigators. A two-way dialogue system online also allows tipsters to come back and provide additional information and ask questions.

A community board of directors meets regularly to evaluate arrests and determine reward amounts.

## **Parker County Crime Stoppers Assists in Solving Child Porn Case**

**July 26, 2021 - PRESS RELEASE – Parker County, TX**

Parker County Sheriff's investigators said a Parker County man was arrested in connection with a child pornography case. Parker County Sheriff Russ Authier said the case originated from a Crime Stoppers tip, identifying the man who was suspected of obtaining numerous images of child pornography on his iPad and iPhone.

Sheriff's Crimes Against Children investigators obtained a search warrant for the suspect's iCloud account, where they located approximately 1,000 images of child erotica and child pornography depicting children in suggestive poses and nude sexual positions.

Sheriff's investigators estimate the images of children depicted in the photos were between the ages of 6 and 12.

The suspect was identified as Walker Watt Lawrence, 46, of Willow Park. He was arrested July 21, on six warrants of third-degree felony charges of possession of child pornography and was booked into the Tarrant County Jail. He was released Friday on a \$60,000 bond.

Sheriff Authier said Crimes Against Children investigators worked for several months during the investigation to gather evidence prior to Lawrence's arrest due to the large amount of images. Sheriff Authier also stated the case will be forwarded to the Parker County District Attorney's Office for prosecution.

## **Crime Prevention Tips – National Police Association**

### **Preventing crime**

One of the best ways to prevent crime is to stay informed, aware, and connected with your local resources. If you are curious about the most common issues in your neighborhood and how you can keep you and your family safe, contact your local law enforcement agency.

Otherwise, there are a few basic things everyone should do to help prevent themselves from becoming victims of crime.

Keep your home secure

Check all of your windows and doors. Make sure all entry points have updated locks and keep everything locked when you are away - even just for a few minutes. Keep lights on while you

are away to keep your house from looking empty. If you are going to be away for a long time, ask a neighbor to accept your mail. Consider investing in an alarm system, especially one that alerts local law authorities in the event of a break-in.

#### **Make sure your digital information is protected**

Password protect all of your devices, including cell phones and tablets, with unique passwords. Be aware of what you post on social media - sometimes addresses, locations, or other personal information make their way into photos by accident. If you are posting sensitive information such as photos of your children, vacation itineraries, etc., make sure that your privacy settings are all up to date. Talk to your kids often about what they are doing online, who they are communicating with, and what information they can share.

#### **Safety in numbers**

Whenever possible, travel with a friend or in a group. Never be embarrassed to ask someone to walk you to your car or to your home if you do not feel safe.

#### **Car safety**

Always keep your car locked and avoid leaving valuables in your car - even in the trunk - whenever possible.

#### **Safety for travelers**

If you are going somewhere new, do some research ahead of time to figure out whom to contact in case of an emergency. Familiarize yourself with local customs and laws, especially if you are visiting a different country. Keep important documents and valuables in a safe place while you are sight-seeing - never bring them with you if you can leave them in a secure location at your hotel or residence.

#### **Drug safety**

If you have prescription medications at home, make sure they are stored in a secure location, up high, and out of sight of curious house guests or burglars. Never offer to share medications with someone else - you should be the only one taking your medications. Sharing is not only dangerous, but illegal. Keep your medications organized, in their original packaging, and occasionally keep count to make sure none are unexpectedly missing. Talk with your children and teens often about drug use, consequences of use, and who they can talk to about peer pressure, drug use, or where to go for help if they need it.

## **Another Solved Case by Parker County Crime Stoppers!**

**July 27, 2021 - PRESS RELEASE – Parker County, TX**

Parker County Sheriff Russ Authier stated two suspects have been identified in connection with the theft of a motorhome valued at \$150,000. Sheriff Russ Authier said the theft occurred July 10, in the 15000-Block of State Highway 377 at the Wabash RV & Boat Storage facility.

Sheriff's investigators obtained security footage capturing two male suspects and the suspect's vehicle taking the recreational vehicle.

Both suspects were observed on the security footage entering the storage facility in a gray/silver Chevrolet Silverado 4X4 extended cab, leaving about 40 minutes later with the stolen motor home.

Sheriff Authier said a previous press release seeking the public's assistance in identifying and locating the suspects generated numerous tips and leads. Sheriff's investigators sought the assistance of Tarrant County Regional Auto Theft Task Force and Dallas Police while following up on each tip.

A Crime Stoppers anonymous tip led Sheriff's investigators to identify one of the suspects as James Dean Crow, 38, of Azle. Tarrant County Regional Auto Theft Task Force identified the second suspect as and Joshua Lee Allen, 26, of Fort Worth. Dallas Police investigators recovered the stolen motorhome July 17, in the business district in Dallas.



Sheriff Authier said in addition to theft charges out of the Parker County, Joshua Lee Allen has additional outstanding warrants for evading arrest detention with a vehicle, obstructing a police officer with Benbrook Police Department, criminal mischief from Burleson Police Department and theft of property out of Hood County.

Sheriff Authier said anyone who knows the location of James Dean Crow and/or Joshua Lee Allen is encouraged to contact the Parker County Sheriff's Office at (817) 594-8845 or Parker County Crime Stoppers.

Crime Stoppers will pay up to a \$1,000 reward for information leading to the arrest of the suspects involved. You may remain anonymous when submitting information to Crime Stoppers.

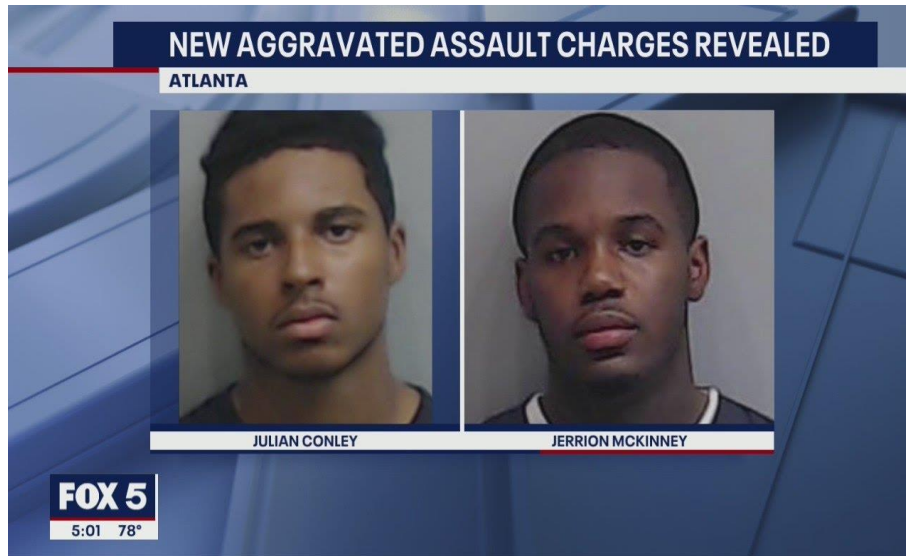
## **Greater Atlanta Crime Stoppers Assists in Solving Shooting of 8-Year-Old and Wendy's Restaurant Arson**

JULY 4, 2020



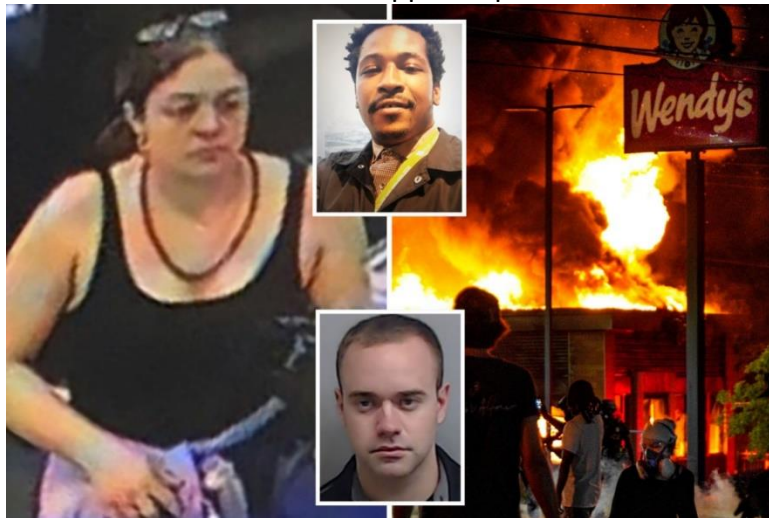

Capture Details: Jaime **ALANIS**, affiliated with the Tango Blast Houston gang, was taken into custody on April 20, 2021 in Corpus Christi, Texas. Working off tip information, members of the U.S. Marshals Gulf Coast Violent Offenders Fugitive Task Force, including DPS Special Agents, located and arrested **ALANIS** at an apartment complex in Corpus Christi. The multi-agency fugitive investigation also included the Corpus Christi Police Department. **ALANIS** had been wanted since July 2020, after the Texas Board of Pardons and Paroles issued a Parole Violation warrant (original offenses: Homicide/Manslaughter and Assault Causes Bodily Injury) for his arrest. Additionally, a Robbery warrant was issued for **ALANIS'** arrest by the Harris County Sheriff's Office on September 25, 2020, stemming from a June 2020 incident in which he allegedly forced a female stranger out of her vehicle and drove off with it after his own vehicle had stalled on a highway in Houston. The arrest was the result of tip information received through Texas Crime Stoppers and a reward was paid.
