All cars and trucks are welcome and must complete registration form prior to the event. Vehicle owners do NOT need to come in costume (although strongly encouraged), however, ALL vehicles MUST be decorated. First, Second and Third Place awards will be awarded, as well as a “People’s Choice” award

EVENT OVERVIEW

Trunk or Treaters will spend the evening going from trunk to trunk, collecting candy from vehicle owners who have decorated their vehicles to serve as the backdrop for this family friendly event. “Trunkers” will be asked to decorate their trunk, tailgate or hatchback and provide candy for the “treaters”.

RULES:

- Registration is free for this event, however all registrations are due by 5p on Friday, October 25th
- All participants must provide their OWN candy for distribution, the Blue Island Park District will NOT provide candy
- Please be courteous to your trunk neighbors and keep your decorations confined to your parking space
- No amplified music OTHER THAN Halloween themed music (no profanity or vulgar language)
- NO electricity will be provided for Trunkers
- Selling is prohibited at this event
- ALL trunks and their owners will be photographed
- Vehicles must arrive NO LATER than 1:00pm and be decorated and ready to go by 2:00pm for official judging
- People’s Choice judging will take place until 3:30pm and will be announced no later than 3:45pm
- Vehicles will not be permitted to move or leave the parking lot until the conclusion of the event
- All vehicles will be assigned an entry number at Check In. Entry numbers must be placed on the right upper most visible location to ensure People’s Choice voters can identify vehicle
- Vehicle owners must provide proof of insurance, vehicle registration and driver’s license with registration form. Only properly registered vehicles will be allowed to participate in this event. License plate numbers will be verified at event
