 - Email or Dropbox 5 -10 of your best photos, video walk-thrus and/or drone footage for each project. “After” pictures only please.
 - Obtain written permission from property owner(s) to use these images. [see attached sample template or use your own]
 - Meet the criteria (listed on the participation form) and we will feature your creations on the ‘Your Home - Your Paradise’ website (HomeParadise.org). Designed specifically to showcase these projects and promote your company.

- **Projects must be submitted before January 15, 2021.**

- **This is only available to LINLA Member companies in good standing. Register or renew now to qualify.**

- **Once the website is launched ,we Go Live to the public.**
 - A selection committee will choose a small number of projects to be featured in a high impact visual presentation.
 - This will be packaged and pitched to; print, broadcast and digital platforms.
 - The object is to drive people to the ‘Your Home - Your Paradise’ website where they can view all of the projects and connect with their creators.
