Please be advised that Ms. Elizabeth Barris has recently consulted with our office regarding her request.

According to Ms. Barris, there are apparently illegal installations of wireless facilities going up within the County of Los Angeles and specifically, within Topanga.

Ms. Barris informs us that she believes the following: a company by the name of Ericsson Inc., with a principal place of business located at 6100 Sprint Parkway, Overland Park, KS, 66211, has been unlawfully installing "RF-Extreme" wireless transmission facilities, without first obtaining any permits or approvals from the County.

Ms. Barris further informs us that she has photograph showing the trucks performing the installations bear the name "Ericsson" on the doors, as well as the company's USDOT registration number.

Ms. Barris reveals to us that she has obtained the company's information, including its legal name and principal place of business, from the United States Department of Transportation.

Ms. Barris also tells us that the installers, when confronted, admitted that their company had not obtained permits, and concomitantly, that County did not authorize the installations.

Ms. Barris reports to us that the installers then ceased the respective installation at the location where they were confronted, but they are apparently proceeding to install other illegal facilities at various locations within Los Angeles County and specifically, within Topanga.

Ms. Barris hereby respectfully requests that the County direct Ericsson Inc. to immediately cease and desist from any and all installations of wireless facilities within the County, for which it has not obtained approvals from the County and to the extent that Ericsson has installed any wireless facilities without proper permits, that they immediately be removed. Ms. Barris also points out to us that, inasmuch as these facilities are being installed at elevations below 200 feet in height, they are not required to be registered with the FCC, and, upon information and belief, they are not being tested by the FCC. Ms. Barris indicates to us this means that, to the extent that Ericsson has, and continues to, install these *RF-Extreme* wireless facilities within the County without County approvals, the FCC has, and will have, no idea where they are, much less the level of RF radiation to which they are, and/or will be, exposing County residents.

Ms. Barris would also like to inform you that she and others in Topanga have made repeated attempts to obtain documents from the County regarding the installation of these wireless facilities though a FOIL request with the County. However, to date, these requests have gone largely unanswered, or answered incompletely.

Finally, Ms. Barris tells us she in receipt of your response to her FOIL request and she expects you to comply and follow through with her good faith request.
