## **Planned Parenthood to Close Three Locations in Northern California**

(Sacramento, CA) – Planned Parenthood Northern California is set to close three locations, including Vacaville, Pittsburg, and central Richmond, on June 30<sup>th</sup>, according to local pro-life leaders and confirmed by a Planned Parenthood spokesperson. These California closures follow closely after Planned Parenthood's recent announcement of closing ten locations in Iowa, New Mexico, Wyoming, and Colorado. Abortions through 10 weeks of pregnancy, using the Abortion Pill, were done at these three northern California Planned Parenthood locations.

“As more Californians understand the humanity of the child in the womb, abortion rates continue to drop and as more women decide to go elsewhere for their comprehensive healthcare needs, there are fewer clients going to the nation's largest abortion business” said Wynette Sills, Director of Californians for Life. “There are other comprehensive medical clinics in each of these communities where women can receive the care they need, without Planned Parenthood. In Vacaville, women can receive comprehensive primary medical care, Ob-Gyn appointments, STI/HIV testing and treatment, and pre-natal care, with same day appointments for both acute and chronic conditions at the Vacaville Family Health Services and the Vacaville Community Medical Center, which is located in the very same building as Planned Parenthood. In Richmond and Pittsburg, Contra Costa Health Services and La Clinica have over a dozen nearby convenient locations, which according to their websites, provide affordable healthcare services to women, including PAP smears, breast exams, referrals for mammograms, primary care, short notice/same day appointments, ultrasound services, even diagnosis and treatment plans for patients with complicated medical conditions.”

Planned Parenthood Northern California Affiliate's Annual Report for 2016 shows their revenue exceeded \$50 million dollars a year, while their expenses were only \$45 million, leaving over \$5 million dollars in excess revenue. “Clearly there is no shortage of funds, including millions of dollars in tax payer money for Planned Parenthood. As their client numbers decline, this money should be re-directed to non-abortion, comprehensive health care providers for women” said Sills.

“Especially after the Planned Parenthood investigative videos showing the abortion industry harvesting baby body parts, there is increased public opposition to the nation's largest abortion business, Planned Parenthood. Women are deciding to go elsewhere for their healthcare needs and therefore, we will likely see even more Planned Parenthood locations close in California and across the nation. More women know the humanity of the child in the womb, have experienced the pain of abortion and are getting the help they need when facing an unexpected pregnancy, so that the number of abortions, even here in California continues to decline, which is financially impacting the abortion industry” Sills continued.
