See an increase in crime and have made several arrests on boats that have been found in the camps.

Ross Island- Working on a truss pass process and an ownership for the state of Oregon. To help take care of the transient boat problem.

Influx of camps around Hayden Island and the Red Lion area. Crime has continued to Rise and request even a 10-dollar lock to deter. Transient boat has picked up at Hadley's landing, and Sauvie Island boat ramp.

Columbia county has a temporary summer help for river patrol. The no wake zone, from Waverly YC and hawthorn bridge have been giving warnings as most people are unaware to the change.

Questions:

1. What are the size and types of boats – Recent thefts have been small outboards from 5 to 20 hp and dinghies.
2. Are you seeing any boat houses broken into currently - none at this time that they are not seeing?
3. Are we going to have problems with fires on the island? State parks are doing their patrols for the fires.
4. What is the water coverage? Two crews each day. One in the morning and one in the afternoon.
