Re: Senator J.B. Jennings advocates for Maryland taxpayers - and wins; State rescinds hiring program funds

Harford and Baltimore County, MD - On Tuesday, July 29, 2025, Secretary Helene Grady of the Department of Budget and Management (DBM) rescinded the budget transfer meant to expedite the hiring of laid-off federal employees. Senator Jennings had voiced his opposition to this hypocritical funding decision and is pleased to have received a communication directly from the Secretary regarding her decision to rescind Budget Amendment 077-25, which would have transferred \$30,000 from the Dedicated Purpose Account (DPA) to support Governor Wes Moore's expedited hiring program for former federal employees:

"I appreciate DBM's decision to withdraw this amendment. At a time when the State is offering \$20,000 buyouts to long-serving employees and implementing a hiring freeze due to our budget crisis, it is unconscionable to continue siphoning public dollars into a program that has shown minimal results. Since February, only 17 of 251 hires came through the expedited hiring initiative. Nearly \$1.97 million of the original \$2 million appropriation remains unused," stated Senator Jennings.

The Senator sits on the Budget and Taxation Committee and led the discussion in suggesting that the Governor consider a hiring freeze to alleviate the FY26 budget deficit. This transfer announced after the session ended and the budget was finalized drew the Senator's particular concern given that agencies have been told not to fill vacancies. Ironically, DBM was preparing to bring on two part-time contractors with these funds. The contradiction was too stark to ignore.

On July 17, Senator Jennings formally raised these concerns in a letter to Secretary Helene Grady of DBM. The Senator requested clarification on how this initiative aligned with state cost-saving measures, what evaluation metrics were in place, and whether the funds would be better allocated toward mitigating the deficit.

On July 29, DBM formally notified the Legislative Policy Committee that it was rescinding Budget Amendment 077-25. In their letter, DBM acknowledged the hiring freeze and confirmed that further waves of the hiring initiative are now on hold.

"Maryland's working families deserve better than mixed messages and misplaced spending," Senator Jennings added. "This rescission is a small step in the right direction toward restoring fiscal discipline and accountability."

Dear Secretary Grady,

I am writing to express concern regarding Budget Amendment 077-25, which proposes the transfer of \$30,000 from the Dedicated Purpose Account (DPA) to support expedited hiring efforts for former federal employees under the Governor's Federal Employees Expedited Hiring Program.

While I recognize the value of attracting skilled personnel to state service, this transfer raises questions, particularly when viewed alongside other ongoing policies. The State is currently offering up to \$20,000 in early retirement incentives to encourage long-time state employees to leave the workforce, presumably to reduce costs and streamline operations. Simultaneously, we are actively transferring funds to bring in additional former federal employees.

Further complicating the matter is the fact that the State is reportedly operating under a hiring freeze. In this context, it is difficult to reconcile the decision to continue funding and prioritizing a hiring initiative for former federal employees, particularly when only 17 out of 251 hires since February 2025 have come through this expedited program, and nearly \$1.97 million of the original \$2 million appropriation remains unspent.

In light of these contradictions, I respectfully request clarification on the following points:

- How does the federal employees expedited hiring initiative align with the State's stated cost-saving measures, including early retirements and the reported hiring freeze?
- 2. What criteria are used to justify the hiring of former federal employees, especially in part-time or contractual roles, when state agencies are under the governor's orders to not fill these vacancies internally?
- 3. What evaluation metrics is DBM using to determine whether this program is achieving its intended outcomes?
- 4. Is there any review underway to assess whether this transfer is necessary, or whether funds should be reallocated to address the state's current multi-billion-dollar deficit?

These are important questions as we work to ensure transparency, fiscal responsibility, and effective personnel management across the State government. I appreciate your time and attention to this matter and look forward to your response.

In a letter dated June 17, 2025, the Department of Budget and Management (DBM) submitted the attached budget amendment (077-25) to the Legislative Policy Committee, the Senate Budget and Taxation Committee, and the House Appropriations Committee, pursuant to Section 7-310(d) of the State Finance and Procurement Article. This budget amendment would have transferred \$30,000 from the Dedicated Purpose Account to the DBM Office of Personnel Services and Benefits to support the program, including two contractual employees to assist in the implementation and management of the program. We appreciate the Department of Legislative Services review of the amendment. However, please accept this letter as notice of DBM's intention to rescind the budget amendment.

To mitigate the impact to Maryland and Marylanders from federal employees losing employment and to help attract critical skills needed in State government, Governor Moore issued a Directive to DBM to establish the Expedited Hiring Program. Following that Directive, SB1040 established the Expedited Hiring Program in the DBM for the purpose of hiring eligible applicants for vacant skilled and professional service positions in the State Personnel Management System (SPMS). The bill, emergency legislation, required DBM to identify job titles and positions equivalent to federal positions for the purpose of filling critical and hard-to-fill roles. DBM was also required to dedicate resources towards the recruitment of former federal workers, including marketing and recruitment activities for hiring into vacant positions. Prior to the hiring freeze announced in late June, DBM had undertaken the first wave of the Displaced Federal Workers Hiring Initiative through which more than 7,000 applications were reviewed. Since the hiring freeze has been announced, DBM is pulling back the budget request and is on hold with additional waves of the expedited hiring program as we assess ways to target these efforts to those critical state jobs that remain open for recruitment.
