● **Jacquelyn Ottman** is the past chair of the Manhattan Solid Waste Advisory Board and, long term board member of her NYC cooperative building and, author of the guide "Engaging Residents of NYC Multifamily Buildings in Mandatory Organics Collection"
Ms. Ottman founded a method to bring her multi-family building's residents to voluntarily sort food scraps years before this new law's requirement.

● *fyi... My understanding of NYC's Curbside Composting Local Law is that NYC Residents must separate their kitchen scraps from regular garbage BUT building ownership is hit with the Dept of Sanitation FINES when kitchen scraps are found in the regular garbage put out on the sidewalk.*
