Consider becoming a board member of the Diamond Business Association's Board of Directors and nominating yourself, or another business owner, to participate in the board elections to take place at the Shine Bright Awards & Annual Meeting on Tuesday, June 20, 2017 at 5:30 p.m. at a location to be determined in the future. Three (3) seats on the Board will be up for election for two (2) two-year terms. Terms commence July 1, 2017.

For the board election, the requirements are:

- 1) Must be a Diamond BID business member in good standing;
- 2) Must have attended two board meetings before the June Annual Meeting;
- 3) Must be willing to attend two meetings a month (one board meeting and one committee meeting);
- 4) Have an interest in how the Diamond Business District can be improved; and
- 5) Possess a desire to bring more customers to the Diamond Business District.

The rewards are that you will have a say in how your money is being spent; know more about what is being done to bring new customers to the Diamond; and have a forum to share your ideas.

Any Diamond BID member may place in nomination the name of any Diamond BID voting member. If you are a voting member you may place your own name in nomination. Each person who is nominated for office will confirm their nomination at the May 2017 board meeting or will be contacted by the Nominations Committee before that date, and asked to accept or decline the nomination.

Nominations will also be taken from the floor at the Annual Meeting on June 20, 2017, after which nominations will be closed. Any nominations taken on the floor will not appear on the slate postcard that is mailed to all Diamond BID members.
