A pre-bid meeting for this project shall be held by Mr. Brent Marsh on Tuesday, June 2<sup>nd</sup>, 2020 at 8:00 A.M., Local Time. The meeting shall be held at the WSOR Janesville Yard located at 203 S Pearl Street Janesville, WI 53548 (see attached Location Map). Should you need directions please call Mr. Marsh at (414) 750-6433. Following the meeting, a tour shall be conducted of the subdivision(s) included in the project. This tour shall likely take much of the day to complete, the tour will dismiss from the field at the last crossing location. To assist in tour planning, contractors are strongly encouraged to contact Mr. Marsh to RSVP a minimum of 24 hours prior to the pre-bid meeting. All individuals attending the pre-bid meeting shall provide and wear personal protective equipment including a hard hat, safety glasses with side shields, and laced safety toe work boots at least six inches high. **A company representative must attend the pre-bid meeting for a company's bid to be considered. The deadline for questions following the Pre-Bid Meeting shall be Friday, June 5<sup>th</sup>, 2020 at 5 pm. All questions must be emailed to Mr. Marsh.**

Sealed bids must be returned to Mr. Marsh by 1:00 P.M. on Thursday, June 11<sup>th</sup>, 2020 at the Wisconsin & Southern Railroad, 1890 E. Johnson St. Madison, Wisconsin 53704. Contractors shall fully complete and sign the enclosed PROJECT BID FORM, incomplete bid forms shall not be considered. Bids shall be sealed in an envelope clearly marked "Waukesha Subdivision 2020 CWR Installation Project – Sealed Bid".

The Wisconsin & Southern Railroad reserves the right to accept or reject any and all bids if it is determined that the bids are non-responsible. Acceptance of a bid shall only be made, and shall only be effective if made, by the Wisconsin & Southern Railroad in writing. All modifications to the project documents shall only be done by written addenda. All addenda received by the contractor shall be acknowledged on the completed Project Bid Form.


