- Makes arrangements for a lottery on behalf of a society (remote/non remote) $\qquad$
ELM requires operating licence from Gambling Commission $\qquad$
- LCCP - conditions apply. 16+

Advertising lotteries
$\qquad$
- Generally lotteries have a low risk of underage/irresponsible gambling. $\qquad$
- ASA CAP/BCAP Codes regulate lottery advertising:
$\qquad$
- No strong appeal to under 18s
- No persons or characters followed by under 18 s (with exceptions) $\qquad$
- No under 255 in a significant role (with exceptions) $\qquad$
- Must not exploit cultural beliefs or traditions about gambling or luck
