## Section XX Licensing of Beauty and Aesthetics Treatments

- (1) No person shall carry on an activity to which this subsection applies
  - (a) except under the authority of a licence for the purposes of this section
  - (b) other than in accordance with specified training
  - (2) Subsection (1) applies to an activity which is specified for the purposes of the subsection by regulations made by the Secretary of State.
  - (3) A person commits an offence if he contravenes subsection (1)
  - (4) The Secretary of State may by regulations make provision about licences and conditions for the purposes of this section...
