## Report on the March CiF: Running for Political Office



On March 28 Mia Phifer of Mia Phifer and Associates spoke to about 50 League members and friends about

modern political campaigns at the **Chicago in Focus** series cosponsored by LWVChicago and the Union League Club of Chicago. Phifer is an experienced political consultant—she has worked on municipal, state legislative, gubernatorial and US Congressional elections since 1997—and focuses on working with women and first-time candidates.

### Fundraising



Campaigns run on money, and it is hard work to raise it. A potential candidate must identify and evaluate resources, beginning with family, friends and close associates, then moving to classmates, professional acquaintances, neighbors

and business contacts. She must then track all contacts in spread sheets. Along with each contact's name, address, telephone and e-mail, the lists should include context: Is the person a family member, friend, neighbor, schoolmate, member of a church or organization? The lists also include requests and responses as well as dates and amounts. This information is important, because big donors want to know the number of individuals who have contributed as well as the average contribution amount.

Big donors and organizations expect a candidate to approach them and respond to questions about issues as well as campaign plans, particularly fundraising. A candidate should be prepared to discuss her background and previous successes, her expectations for the campaign and goals in office. Phifer said that this preparation makes sure the candidate hasn't auditioned for a role and then found that she will be performing in a different play.

### Planning and Organization



Planning is crucial to fundraising success. The proverbial boiler room includes several staff members or volunteers and the candidate who

prepare the campaign message, generate call lists and identify the number of calls per hour and expected

results. Campaign staff record the number of calls and their results per hour. Calls for fundraising typically total 40 hours in a five-day week.

A candidate must not only want to win but know how to win. The "how to" comes from professional fundraisers and message consultants. While the candidate controls the message and public perception, message consultants shape effective communication and respond to issues and questions as they arise. Volunteers are key components of any campaign, but their time may be limited. A candidate therefore must rely on the support of staff who are immediately available to respond to whatever comes up. A function of paid staff is to train volunteers, but it is up to the candidate to tell supporters what is needed.

### Campaign Costs and Financing Reform

The costs of campaigns vary. It is more costly to run against an incumbent than to run for an open seat. Candidates financing their own campaigns raises the possibility that public office will be available only to independently wealthy. Phifer suggested that campaign finance laws permit a campaign to pay the candidate a stipend if the candidate's income is less than a fixed amount set by law.

### Where to Start

Phifer urged members of the audience to consider running for office. In Chicago, local school councils are a great place to begin. The councils are local and involve neighbors and friends in the school area. So begin collecting those lists—and save them; they will be useful, if not now, then the next time.

- Members will conduct the "business" of LWVChicago: electing officers and directors, approving the proposed budget and changes to bylaws and program for the next year.
- A report detailing the activities and accomplishments of the past year will be presented.
- Plans and goals for next year will be developed.

## Health Care Issues Report

### The Affordable Care Act



The American Health Care Act to repeal and replace the Affordable Care Act was not brought to a vote in March. The Republican House Freedom Caucus and the

moderate Tuesday Group have been negotiating changes to the act and planned to resubmit a bill by April 28, according to *Business Insider*. A tall order for Congress, which also has to pass a budget to avoid a federal government shut down. At the time of writing, it is unclear what action will be taken on this issue in the next few weeks.



During the April Congressional recess, LWVIL worked with the Protect Our Care IL

Coalition to lobby Illinois Representatives, urging them not to repeal the ACA without an adequate replacement. Advocacy focused on seven Illinois Congressional Districts whose Representatives expressed support for repeal of the ACA: 6<sup>th</sup> district, Peter Roskam; 12<sup>th</sup> district, Mike Bost; 13<sup>th</sup> district,

Rodney Davis; 14<sup>th</sup> district, Randy Hultgren; 15<sup>th</sup> district, John Shimkus; 16<sup>th</sup> district Adam Kinzinger; and 18<sup>th</sup> district. Darin LaHood. For months many groups have held rallies encouraging these Representatives to hold Town Hall meetings with their constituents and discuss many concerns, including the ACA. Local LWVIL Leagues arranged Question and Answer Sessions in two districts: on April 18 with Rep. Hultgren and on April 22 with Rep. Kinzinger. Both events were well attended.

### Illinois Reproductive Health



On April 25 the Illinois General Assembly passed HB40. This bill repeals a trigger provision in the 1975 Illinois Abortion Law that states if Roe v Wade

is ever overturned or modified by the US Supreme Court, Illinois will revert to its pre-Roe law that made abortion a criminal act. This bill also allows women covered by Medicaid and the State Employees Health Insurance to obtain insurance coverage for abortion care. The bill now moves to the Senate. On April 14 Governor Bruce Rauner's office announced he will veto the bill if it passes the Illinois Senate.

LWVIL issued a Time for Action (TFA) requesting that members contact the Governor and ask him to reconsider this decision.

Its purpose is to examine results of the first of a four-year plan to improve health equity in the city. Some committee members have RSVP'd and look forward to what can be learned from this event.
