



- Police Athletic League



- Jay Mallin's documentary on the Talbot Bridge connecting Lyttonsville and downtown Silver Spring (see video [here](#))


Create a curated STJNs resource bank/site of materials we find inspiring or transformational


Develop truth-telling opportunities


