
SADC INDUSTRIALISATION WEEK

The event is hosted on the margins of the annual SADC Heads of States and Government Summit. Private sector recommendations and outputs from this event are reported directly to the annual SADC Ministers Meeting, a body which determines policy discussions for Heads of State.




