#### **How to Apply**

**APPLY HERE** or mail an application or turn it in at the MySpokane Customer Service counter at City Hall; 808 W. Spokane Falls Blvd., Spokane, WA 99201

#### **City Residency Required**

All applicants to City boards, commissions or committees must be residents of the City of Spokane, unless the provision establishing the requirement for the appointment specifically permits or requires the appointment of a nonresident. Not sure if you live within City limits or would like to verify which Council district you live in? Use the **map tool** to verify your address.

#### **Open Public Meetings Action & Public Records Act Training Required**

As part of your appointment, you shall, within ninety (90) days of your appointment letter, complete training regarding the Open Public Meetings Act and the Public Records Act. The training can be completed online through the Attorney General website at **<http://www.atg.wa.gov/open-government-training>**. You will need to review the written material under Lesson 1 regarding open government and then watch the videos under Lesson 2, regarding Public Records Act training, and Lesson 3, regarding the Open Public Meeting Act training. Once you have completed the training, you can upload the attached certificate of training and file the certificate with the City Clerk's Office. ### **Spokane Employees' Retirement System Board (SERS)**

The Spokane Employees' Retirement System (SERS) is a multiple employer defined benefit pension plan covering employees of the City of Spokane.

Management of SERS is vested in the SERS Board, which consists of seven members: three members are elected by active employee plan members, three members are appointed by the Spokane City Council, and one member (who may not be an elected official or employee of the City) is appointed by the other six board members. All board members are volunteers. The plan is seeking a qualified candidate for one of the members appointed by the Spokane City Council.

#### **SERS is seeking a highly qualified candidates who meet the following criteria:**

1. 10 years of investment experience or 5 years experience as a fiduciary.
2. Demonstrated high ethical standards in both their personal and professional lives.
3. Understanding of defined benefit plans and an institutional investing framework to include asset class diversification, asset allocation studies, the screening, selection, and oversight of investment managers, and the effective use of benchmarking criteria.
4. Bachelor's degree in related field required, with advanced degree or professional certification (e.g., CFA, CPA, or CFP) preferred.

### Ethics Commission

It is the policy of the City of Spokane to uphold, promote and demand the highest standards of ethics from all of its employees and City officers, whether elected, appointed or hired. The Code of Ethics sets forth requirements that are applicable to employees of the City of Spokane, and it is the duty of the members of the Ethics Commission to receive complaints and other requests, judge their merit based upon evidence submitted and move through a defined process to determine what, if any, sanctions should be made against an employee found to be in violation of the Code of Ethics.

Applicants who wish to serve on the Ethics Commission should review the full Ethics Commission Policy and Procedures, as well as the Ethics Commission Handbook.

**Individuals from the following segments are encouraged to apply:** Professional or academic background in the legal profession, OR experience in human resources, OR possessing familiarity with government and the political process, OR experience in ethics.

**Meeting Information:** Meetings are generally held quarterly, or when an ethics complaint has been submitted for consideration.
