49th Meeting of the AFA Board of Directors



The 49th Annual AFA Board of Directors (BOD) Meeting will take place this week in Las Vegas, Nevada. AFA Local Executive Council (LEC) Presidents from each of the 18 AFA represented airlines, Master Executive Council (MEC) Officers, International Officers, members, and guests will join together for an in-person meeting.

Your Local President represents you and the other members of your Local Council on the Board of Directors and will be casting votes on and with the full strength of your council at the BOD meeting. MEC Officers at multi-council airlines serve in an ex-officio capacity on the BOD. Only officers directly elected by members can cast votes.

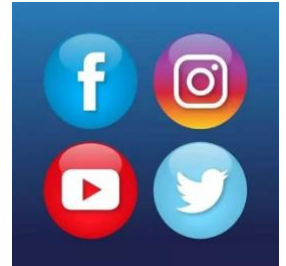
A total of nine Advance Agenda Items have been submitted for consideration by the Board at this meeting. Each Local Council conducted a local council meeting last week in advance of the BOD Meeting to solicit views from members on the agenda items. In addition to the consideration of agenda items, AFA International Officer elections will also take place at this year's BOD meeting. As your directly elected representative, your local President will be voting for the offices of International President, Vice President, and Secretary-Treasurer.

Increase of Social Media-Related Disciplinary Cases

One of the most used forms of communication, other than our cell phones, are social media posts on Facebook, Instagram, Tik Tok, YouTube and other platforms that link us together in different countries around the world and time zones.

Unfortunately, AFA has seen an unusual uptick in disciplinary cases within Inflight involving social media where people may feel bullied, harassed or intimidated by some posts. Other social media posts being questioned include opinions, comments and/or perceived unprofessional behavior while in uniform.



Though you are allowed to voice your opinions and feelings on social media, as one's freedom of speech, please be mindful of how your comments may be perceived by others as well as what is said about our employer and fellow crew members. Hawaiian Airlines has a specific company policy regarding social media.
