### AFA Encourages a Halt to the Sale of Alcohol Onboard the Aircraft

On June 28th, MEC President, Joni Kashiwai, sent a letter to the VP of Inflight, Robin Sparling, imploring the company to delay the sale of alcohol until the Federal Mask Mandate lifts in September. Across the nation, passenger mask compliance issues have caused inflight disruption and sometimes even physical violence. Alcohol on the aircraft has the potential to elevate situations further than normal. AFA believes that for the safety of our crew members and passengers, the company should acknowledge and grant our request. ### Recall List



According to our contract, when recall is conducted, Crew Scheduling must provide a list of Flight Attendants who have received recall. This list is published on the IFS website under the "Daily Flight Schedule" tab. Unfortunately, this list is not automated and must be inputted manually. For the past few months, 47 leaders have had to reach out to Crew Scheduling requesting them to update the recall list. We are working with the company, asking them to be more consistent in updating the list as it is a potential contractual violation. If you believe you were bypassed for recall on any given day, please file a Scheduling Clarification Form (SCR).

Often times, the company does not notify us of a certain issue so we are not aware and therefore cannot address the issue on our weekly calls with the company.
