LEC Recall Petition, Results

Dear Fellow Flight Attendants –

The AFA-CWA International (INTL) Office advised the Council 43 Officers that three petitions were received on July 19, 2022. [Please see the attached from International Secretary-Treasurer Dante Harris.] This recall was and can be initiated by Members and I respect that process in accordance with the [AFA-CWA Constitution & Bylaws](#) (C & B). Up until today, the C43 Officers have not commented or spoken to the petition efforts. I will address it here.

As many of you know, our leadership has always worked as a collective. Yet, this recall campaign, while including both the LEC Vice President Kahea Ching and LEC Secretary Kerri Chow Ruiz, appears to have primarily targeted me. And while I would like to believe that I am resilient, this recall campaign has affected and struck the entire C43 leadership team and many of the volunteers.

Anyone can say that this petition is about me because of personal feelings they have toward me as the LECP. But this goes beyond that. The many leaders/chairs that comprise our leadership felt that this recall effort also spoke about them because we all work together to serve the Membership.

Setting that aside, as your LEC President, I don't need anyone to speak on my behalf – I am capable of doing that myself. Individuals can have opinions of me, but that is different from what I do and my intention as an elected officer. So let me be clear, I am here for the Membership. The petitions do not satisfy Article IX.C requiring valid signatures of 30% of the Active Members in Good Standing.
