Recent AFA News


- AFA helped host a rally for Veterans just blocks from the White House this morning. Veterans stood together to say “we will not be erased.”

The National Labor Network for Ceasefire strongly condemns the Trump Administration's attempt to deport Palestinian student activist, legal permanent resident, and former UAW member Mahmoud Khalil and demands his immediate release. Khalil has not been charged with any crime. He is being detained as a warning to the movement for peace and justice in Israel-Palestine—and to all of us who dare to organize or dissent.
