Payroll Support Program (PSP)

Some of you may have seen/heard the news that US President Donald Trump killed the extension of the Payroll Support Program with a single tweet earlier today. This shocking move was a surprise to many on Capitol Hill where the Federal Reserve Chairman Jay Powell supported a relief package to aid working families and our stifled economy. Moreover, the AFA's International office (INTL) said 92 US Senators had bi-partisan support to provide immediate relief including help for the airline industry.

Within one hour of Trump's tweet, INTL called an emergency Board of Directors (BOD) meeting for all INTL, MEC and LEC officers. AFA's International President Sara Nelson explained what was being negotiated prior to the tweet. Since that tweet, Sara confirmed that the AFA is working with other labor groups and the airlines. INTL is looking at all options available to us so that we can do what we need to protect Flight Attendant jobs and the flying public.

Sara Nelson, "Our union is not one person, one airline or one local. It is all of us. This is a tough time and people are struggling and feeling alone. The first and most urgent thing to do is know that we are here together through our union and spirit as Flight Attendants."

Neighbor Island Flight Cancellations - update

The company increased its interisland flight schedule in anticipation of increased flight arrivals starting October 15. However, schedule changes and flight cancellations are occurring due to the lack of passenger capacity. Check ID90 and hawaiianair.com regularly to verify your flight is operating if commuting to/from a neighbor island; there may be unanticipated flight cancellations.
