February Bidding Timelines

There is a lot going on in the month of February. To help lessen the confusion as to the different types of leaves and bidding timelines, we have provided a chart for the timelines and descriptions of each leave. As you will see, there will be another round of VEOP's (Voluntary Early Out Program) and another round of 16.L Leaves to help offset the potential furlough if PSP is not extended.

Voluntary Early Out Program ("VEOP")

Any Flight Attendant who is at the seventh (7th) year pay step (\$49.74) as of April 1, 2021. Eligible employees will have from February 8, 2021 at 09:00 HST - February 22, 2021 at 17:00 HST to request a VEOP. There will be a rescission period from February 23, 2021 at 09:00 HST – March 1, 2021 at 17:00 HST to rescind their VEOP

Election. VEOPS will commence on April 1, 2021. The provisions of this VEOP offering are the same as the October 2020 VEOP. Details on the VEOP program can be found by [Clicking Here](#).

COVID-19 1-month Leaves/Low-Time Lines

The Company will continue to offer 1-month at a time COVID-19 leaves and low-time lines. The bidding period is currently open through February 15, 2021 at 17:00 HST. If you would like a leave for the month of March 2021 only, this is the method to do so. These leaves will **not** offset any involuntary furloughs.

Section 16.L. Offset Leaves/Extension

The Company is still firming up the dates for the bidding period to begin, but it looks like in mid-February we will be offering the 16.L. offset leaves/low-time positions in duration of 6-months to begin on April 1, 2021. These leaves and low-time lines will be used to offset the total number of involuntary furloughs. 100% company-paid medical coverage for 6-months will be provided to all applicants.

Section 17.N. Leaves

Long-term and short-term leaves offered monthly per Section 17.N. of the CBA.

Inflight Commuter Policy

As you all know the AFA was successful in negotiating an Inflight Commuter Policy into our Collective Bargaining Agreement (CBA). This policy allows protections to registered Flight Attendants commuting from a city other than where she/he is based. This policy also protects registered Flight Attendants from a performance infraction if she/he is unable to report for duty after complying with the procedures listed in the Letter of Agreement.

Registered Flight Attendants may choose to utilize or not utilize the provisions and protections outlined in the policy. The provisions apply to commuting on any scheduled air service flight – HA flights as well as non-HA flights. If a FA is living in a city other than her/his designated domicile, she/he must designate an airport as her/his “registered commuter city” with inflight management and such designation will extend to all airports in that metropolitan area within a 100-mile radius.

Additionally, the policy outlines the definition of a “commuting failure”, the process of notification to the company in the event of a commuting failure, and what documentation will be required.
