LEAVES, LOW TIME LINES and VOLUNTARY FURLoughs

The company is coordinating their efforts to provide information for our Flight Attendants as they return from leaves or go out on leaves. If you have any questions, please call the in-flight COVID hotline 808.835.3383, daily from 400 am – 900 pm.

Q: Do you know if the company is offering leaves in June or July?

A: The company is continuously evaluating our flying schedule and therefore staffing levels. As you may know, the COVID-19 Temporary Contract Modifications is valid through July 2020. However, as we continue to monitor the State of Hawai‘i's 14-day mandatory quarantine, our schedule may change. In the past, the company had extended leaves on a month-to-month basis in order to off-set any potential involuntary furlough. We believe extending leaves may be possibility beyond May 2020.
