Dear Flight Attendants,

The Association of Flight Attendants entered into an official Partnership with the Department of Transportation and the Department of Homeland Security becoming the first labor union to secure a memorandum of understanding and participate in the Blue Lightning Initiative campaign. This official partnership has provided us with an opportunity to create co-brand identification and prevention materials and bring the Blue Lightning training to thousands of Flight Attendants.

RECOGNIZE AND REPORT HUMAN TRAFFICKING

Human trafficking involves the use of force, fraud, or coercion to obtain some type of labor or commercial sex act.

Any minor (under the age of 18) engaged in commercial sex is a victim of human trafficking according to federal law, regardless of whether there is force, fraud, or coercion.

INDICATORS OF HUMAN TRAFFICKING

If you observe the following indicators of suspected human trafficking activity, you should report them right away.



No control of travel identification/documents



No freedom of movement/social interaction



Difficulty articulating reasonable/logical travel plans



A non-genuine relationship; particularly parent/guardian-child

On the Ground

Report human trafficking 24 hours a day, 7 days a week by calling ICE/HSI tip line

In the event of an emergency, call 911 or contact local authorities

In-Flight

By following your **airline reporting protocol**

Flight-deck communications: Aircraft communications addressing and reporting system or domestic event network

Without compromising their anonymity, contact a **Federal Air Marshal** on your flight. This is a **LAST RESORT**.
