Council 43 Grievance and Reserves, update

Dear Fellow Flight Attendants –

After our review of the past week's Scheduling Clarification Review (SCR) forms, we hope that the following may help some of you moving forward.

DAILY FLIGHT SCHEDULE (DFS) POSTING

The contractual language cites when the Company is required to post the Daily Flight Schedule (DFS). Per Section 11. Scheduling Policy, F. Printed Daily Schedule (Daily Flight Schedule),

The Printed Daily Schedule shall be dated and the time of completion shall be stated thereon.

Thereafter no changes shall be made in the Printed Daily Schedule except as provided in the Agreement. A separate Daily Flight Schedule will be issued for International flights and Inter-Island flights.

The International Daily Flight Schedule will include all International flights for all domiciles.

The Inter-Island Daily Flight Schedule will include all flights for the Honolulu domicile. The Inter-Island Daily Flight Schedule and the International Daily Flight Schedule will be posted in the Flight Attendant lounges not later than 1700 hours HST. Further, a copy of the Daily Flight Schedules as posted at 1700 HST, will be sent by email to the MEC President or designee....

During the launch of the Reserve Self-Assignment (RSA) system in early August, there were days when the DFS was not posted by the mutually agreed upon time. More recently, there was a report of this happening more than a week ago. We have relayed the information to the Master Executive Council (MEC) to help resolve these concerns and for further direction; we will keep you posted.

PREFERENTIAL BIDDING SYSTEM (PBS) TUTORIALS

Coming out of the pandemic and the various changes we went through due to our flights, many of you have questions about bidding and how to maximize the Preferential Bidding System (PBS). Factoring in the new Reserve Self-Assignment (RSA) system, we'd like to remind you that there are resources for you as we bid. For those of you who are not familiar with the PBS tutorials, they are offered to all Flight Attendants leading into and through the bidding process. RESERVES ARE NOT REQUIRED TO ANSWER SCHEDULING CALLS BEFORE/AFTER RAP

Several Flight Attendants have filled out SCR forms about receiving calls from crew scheduling either before or after the Reserve Assignment Period (RAP). Although there were periods/occasions when crew scheduling would do courtesy calls to advise Flight Attendants of assignments before the start of the RAP, crew scheduling will make every effort to refrain from this courtesy. As a reminder, Reserve Flight Attendants are not required to answer crew scheduling calls before and/or after a RAP assignment.
