Airport Reserve

The company has announced that they will begin the **Airport Reserve (ARC)** assignment at LAX. We realize that this is a big change for our reserves but the company's ability to utilize ARC is clearly outlined in Section 8 of the CBA. Changes to our flying schedule as well as late sick calls and sick calls after assignment contributed to the company adding ARC to protect the operation. May 3rd - May 26th there will be 1 ARC to protect the LIH. This ARC will not be legal to be assigned KOA. May 27th - May 31st there will be 2 ARC. 1 to protect LIH and the other to protect the KOA Flight. The FAR allows for minimum crew to be **scheduled** for a maximum of 14 hours. - LIH Turns must have 5 FA's in order to turn
- KOA Turns (May 3 - May 26) staffed with 5 FA's but can turn with 4 FA's because it is scheduled at 14 hours
- KOA Turns (May 27th - May 31st) must be staffed at 5 FA's in order to turn because it is scheduled over 14 hours

CA COVID Supplemental Sick Bank

The company has informed AFA that they are monitoring the frequency in which Flight Attendants are utilizing the California COVID Supplemental Sick Bank. While this is state mandated and our right to use, the abuse of the supplemental sick bank may trigger the company to start an investigation. A scenario that may cause the company to investigate is scheduling a COVID Vaccine appointment, picking up a trip on the vaccination day and then calling in sick. Being that vaccine appointments may be scarce, we understand that this situation may occur and there is no fault in doing so. Just know that this may cause the company to investigate further. An investigation is not discipline, it is considered a fact finding event.
