COVID UPDATE

As many of you have heard, we had a recent COVID exposure in recurrent training. Of importance, HIPPA laws provide that the names of any affected individuals remain confidential. The company has communicated that they are taking the necessary steps to support any employees who were possibly exposed while increasing their social distancing practices. In terms of future recurrent classes and any adjustments, the company will notify the group on what to expect.

Hello, I am a constituent calling to ask [Representative] / [Senator] to help save my job as an essential worker. Take legislative action in July to extend the CARES Act Payroll Support Program for aviation workers in order to avoid massive job loss in October. Keep us connected to our jobs, our paychecks, and our healthcare. Thank you for your urgent attention to this.

UNEMPLOYMENT INSURANCE (UI)

Many of our Flight Attendants continue to struggle with the UI office and having claims processed. Please know that the INTL office has been asking US Representatives to assist in voicing our members' frustrations. And although it has been months, some of you who commute to HNL are finally receiving calls from the UI office to help clear the "flags." Please know that we are continuing to follow-up with as many resources that can potentially help impress the importance of timely claim processing. Thank you to the many of you who continue to help other Flight Attendants through this aggravating and highly frustrating time.
