Council 43 Grievance and Reserves, update

Dear Fellow Flight Attendants –

After our review of the past week's SCRs, we hope that the following may help some of you moving forward.

CREW REST (A330), LAS/LAX/PPG/PPT TURN GROUPING WITH NO LDMCR

Q) What is the contractual reference for crew rest when an augmented turn flight does not have an operable LDMCR?

CBA: Section 7. Hours of Service, D. Legal Rest Minimums, 2. International, f. Rest on Board the Aircraft – International, (12) Rest Seats (a) Primary Rest Seats and (b) Secondary Rest Seats [CBA page 7-15]

(a) In the event that the crew rest facilities are not installed or serviceable for A330/350 flights: For flights regularly scheduled between eight (8) hours and twelve (12) hours block-to-block, "diurnal turns" scheduled to exceed eight (8) hours cumulative flight time block-to-block and/or duty periods in excess of fourteen (14) hours, Flight Attendants shall be provided last two (2) middle rows of the aircraft curtained off for crew rest to a minimum of six (6) seats. The inside seats of those rows shall have retractable armrests.

SUGGESTION: If the LDMCR is not operable, notify the agents advising them of the contractual language. You should also reach out to the In-Flight Duty manager to notify her/him of the situation.

CBA: 3. Compensation, R. Pay and Credit, 2. International, c. (1) [CBA page 3-13]
