Re: Recall of MEC Officers and How We Will Move Forward

Dear Flight Attendants,

My name is Chasity Theno and I am your Acting Master Executive Council President. Earlier today, a Special Meeting was called in pursuant of Article VII.D.2. of our C&Bs by the Council 43 LEC President Jaci-Ann Chung. On the agenda were 2 items; Agenda Item #1: Recall of the Hawaiian Airlines Master Executive Council Vice President and Agenda Item #2: Recall of the Hawaiian Airlines Master Executive Council President.

Sara Nelson (AFA International President) Chaired the meeting. Kevin Creighan (AFA International Secretary/Treasurer) took the meeting notes and AFA staff did their best to verify and admit the active members who were attending the meeting via zoom. There was a discussion for both Agenda Items where the MEC Officers and the 2 LEC Presidents had speaking rights. Per Article VII. D.5.b. these particular agenda items would be voted on with a roll call vote.

Using the numbers that was provided by AFA International, Council 43 Jaci-Ann Chung had a total of 1,379 votes. Council 47 Josh Aoki had a total of 109 votes.

The vote results are as followed:

Agenda Item #1: Recall of the Hawaiian Airlines Master Executive Council Vice President

Council 43/HNL votes for: 1310

Council 43/HNL votes against: 69

Council 47/LAX votes against: 109

Total votes for: 1310 Total votes against: 178 The first item on the agenda passed on a roll call vote.

Scott Henton has been recalled from his position as MEC Vice President.

Agenda Item #2: Recall of the Hawaiian Airlines Master Executive Council President

Council 43/HNL votes for: 1310

Council 43/HNL votes against: 69

Council 47/LAX votes against: 109

Total votes for: 1310 Total votes against: 178 The second item on the agenda passed on a roll call vote.

Joni Kashiwai has been recalled from her position as MEC President.

How Will We Move Forward?

Article VII.C.3.e. of the C&Bs states that "If the offices of President and Vice President become vacant for any reason, the Secretary- Treasurer shall become Acting President and shall call a special meeting within ten (10) days for the election of such Officers under Section D. of this Article."

As the Acting MEC President, I am calling a special meeting to elect a new MEC President and new MEC Vice President on Wednesday, May 25, 2022 at 0900HST/1200PDT via zoom. I will provide additional information in a separate communication.

If you are interested in serving, you must:

- Be an active member in good standing.
- Submit a Willingness to Serve to the MEC Secretary/Treasurer (Chasity.Theno@hawaiianmec.org)
- Agree to the following duties set forth in Article VII [Constitution and Bylaws](#)

If you are interested in both positions, you may submit a Willingness to Serve for both.

Each candidate who wishes to appear before the MEC prior to the elections is able to do so per our MEC P&P. If you do not wish to meet with the MEC, you have the option of submitting a statement. Please include either in your Willingness to Serve submission.
