TOUR ITINERARY

Saturday, April 25 | Welcome to Los Angeles

Arrive in sunny Los Angeles where we will be met by our California tour director. We will start our day with a tour that will include photo-worthy stops at Beverly Hills and Griffith Observatory before checking into the hotel to refresh for our included welcome dinner. Our overnight hotel is the Sheraton Grand Downtown LA.

Day 2: Sunday, April 26 | Scenic Rail Journey on the Coast Starlight

Board Amtrak's iconic Coast Starlight for one of North America's most beautiful train rides. Travel along the Pacific coastline from Los Angeles to Salinas. Upon arrival, continue by private coach to Monterey for your stay at the Hyatt Monterey.

Day 3: Monday, April 27 | Big Sur & Point Lobos

Start the day with a nature walk through the dramatic coastal cliffs of Point Lobos Reserve, led by a local naturalist. Continue along breathtaking Highway 1 to Julia Pfeiffer Burns State Park for a box lunch near McWay Falls. Enjoy the iconic 17-Mile Drive and explore charming Carmel-by-the-Sea before returning to Monterey.

Day 4: Tuesday, April 28 | Gardens, Seaside Towns & Modesto

Begin with a garden tour in Monterey, then continue along the coast with a photo stop in vibrant Capitola. After exploring Santa Cruz's scenic West Cliff Drive, enjoy dinner on your own at upscale Santana Row in San Jose. Overnight in Modesto at the Courtyard by Marriott.

Day 5: Wednesday, April 29 | Yosemite National Park Adventure

Journey into Yosemite National Park through either the southern or western entrance, with time to explore the majestic Mariposa Grove or the iconic Yosemite Valley. Take in the waterfalls, granite cliffs, and serene meadows, with an optional visit to the Ansel Adams Gallery. Arrive in San Francisco late evening and check in to the Hyatt Centric Fisherman's Wharf.

Day 6: Thursday, April 30 | Discover San Francisco

Explore the city by the bay! Highlights include the Golden Gate Bridge, Painted Ladies, Palace of Fine Arts, Japantown, Salesforce Park, Lombard Street, Chinatown, and more. After a full day of sightseeing, enjoy a relaxing evening on your own in Fisherman's Wharf.

Day 7: Friday, May 1 | Alcatraz & Golden Gate Park

Cruise to Alcatraz Island for a fascinating tour of this historic prison. Then, visit Golden Gate Park for a guided stroll through the San Francisco Botanical Garden, followed by free time in the Japanese Tea Garden. In the evening, gather for a memorable farewell dinner on Pier 39.

Day 8: Saturday, May 2 | Departure Day

Private group transfer to San Francisco International Airport. Say farewell to California's stunning coastlines, redwoods, and cityscapes.
