Mason SBDC Counselor and Client at ICAP - GMU's 1st CoHort of 2020

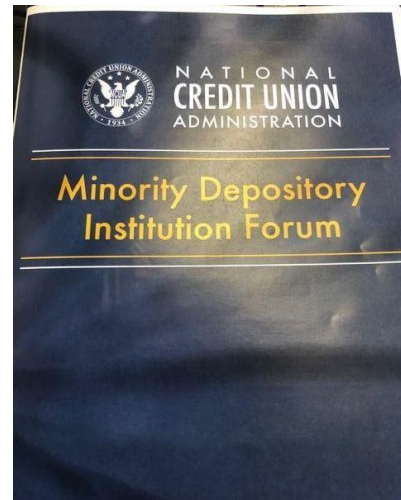
