

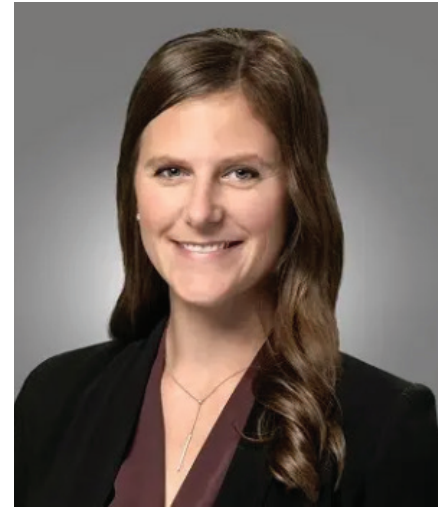


# President's Message
