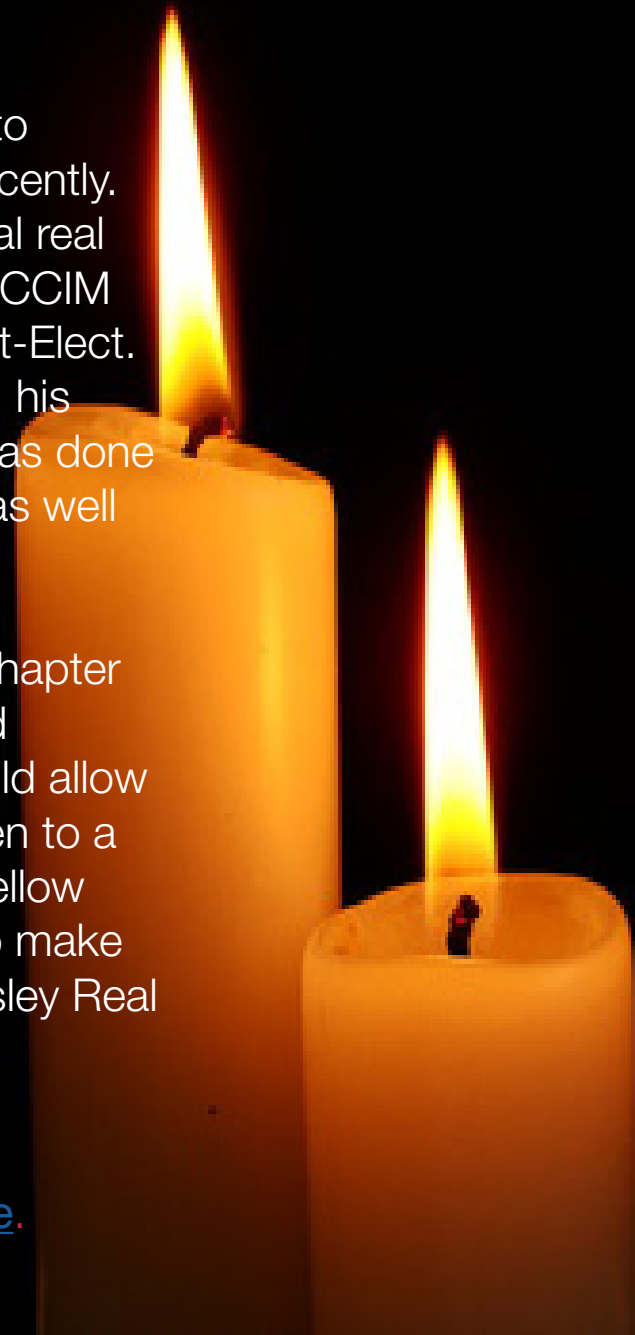
In Loving Memory

Marc Nanne, CCIM represented Sun Country Airlines in the relocation and long term lease of their 90,000 sf Headquarters and other functions to the MSP airport property where they had some hangar use and they occupied 4Q 2019.



Royce Durhman, CCIM, and Brian Ertel, represented LS Capital on the off-market acquisition of 2500 Cleveland Ave N, Roseville, comprised of approximately 41,040 rentable square feet, which closed for \$4,750,000 (\$115.74/sf). The property was fully leased and contained 7 tenants, with Goodwill as the anchor tenant.

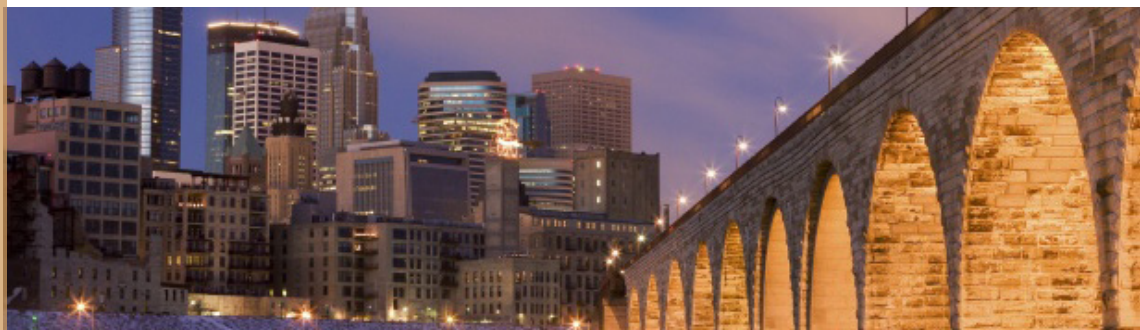
