Probate Court Releases *Caregiver Videos Series* *Help for both family caregivers and professionals*

(Summit County, Ohio - September, 2018) – Caregivers in Summit County now have an additional resource for information and support available through the Summit County Probate Court at www.summitohioprobate.com.

“These videos offer information for family members who are caregivers navigating the system as well as professionals working within caregiving fields,” said Probate Court Judge Elinore Marsh Stormer. “Family members provide crucial service to their loved ones. Our hope is to support them along the way.”

The Senior Summit 2018 Conference brought together leaders in their fields to convey the latest information for those who care for or serve the senior population of Summit County. These videos from that day, explain caregiving subjects such as the Ohio Caregiver’s Act, Parkinson’s Disease: from the patient, researcher and caregivers’ point of views, and the Challenges of Family Caregiving.

“More than 43 million people nationwide fill the role of unpaid caregiver to someone over 50 who is ill or disabled,” shares Maria Schimer, General Counsel at Northeast Ohio Medical University (NEOMED). “Family and friends provide unpaid, frequently untrained assistance to a loved one with a chronic illness.”
