Qualified electors who are African Nova Scotians or the parents or guardians of an African Nova Scotian child are entitled to vote for the African Nova Scotian member of the School Board (Education Act, s 42A). Qualified electors can vote for only one school board office in an election [Education Act, s 49(2)].

Details regarding the various Cumberland County communities and polling station locations on ordinary and advance polling day, October 15, 2016 are as set out above.

GENERAL

It is suggested that voters retain a copy of this notice to facilitate the municipal and school board elections and to help avoid confusion with the upcoming federal election.

Poll locations for Council and School Board elections will be advertised separately.
