

## Crockett Economic Recovery Taskforce Small Business Relief Fund Application

The Small Business Relief Fund was established by the City of Crockett, Crockett Economic Industrial Development Corp. and Crockett Area Chamber of Commerce with oversight from the Crockett Economic Recovery Taskforce from a grant provided by the CARES Act - Coronavirus Relief Fund and will be managed by Crockett Economic Industrial Development Corporation.

**Eligibility Requirements:** Applicants must own a small-business or be self-employed, ten or less employees in the City of Crockett (Crockett address) and must use funds to offset losses due to COVID-19. Priority will be given to businesses that have had to close, lay off employees, limit operations to take-out, curbside or delivery or can show other direct, negative impacts that threaten the ability of the business to continue operations long-term.

The Small Business Relief Fund will provide financial assistance for one or more of the following purposes:

- Business lease or mortgage payments
- Utility Payments
- Payroll for employees still employed
- Critical business operations (raw materials, marketing expense, etc.)
- Other business needs as approved by the fund oversight committee

**Funding Amounts:** Awards range from \$500 - \$1,000 until all funds are expended. After 45 days from date of award, another application may be submitted provided funding is available.

**Distribution:** Distribution will begin in August 2020 and continue until all funds are expended
