So here's the deal:

For many years, and specifically in this format for the past 10 years, *Hawver's Capitol Report* has provided candidate guides on each legislative races, adding new information each election cycle. So, the 2020 House candidate guide was brimming with years' worth of historical information on each district.

Well, because of the 2020 Census and subsequent redistricting, 2022 is almost a start-over year with redrawn districts. Some districts aren't changed any, some have been tweaked, others are gone and replaced by new ones—maybe hundreds of miles away. Overall, districts have changed enough that you almost need to start with a clean slate every 10 years.

We always say with these candidate guides that they're a work in progress because we're always adding new information (including additional contact information on candidates); this year that's truer than ever. We're starting with the basics, of where the districts are, who the incumbents are, who's running for office and their contact information. But even shorthand district physical descriptions may change slightly, when we get official details yet to be released on each district's geography—in the meantime, we're using the general outlines from previous districts.

We'll also have the party registration breakdowns for each district when they become available.

We will be adding as we go forward district-by-district breakdowns of presidential and gubernatorial voting records as they become available for these newly mapped districts so you can see how they have tilted recently. Over the years the results of the House elections will be added to each district's listing.

As we update this document throughout this year and in the future, we'll send new version links to subscribers (with the updated date noted).

To make the document as user-friendly as possible, we've color-coded the heading on each district as follows:

- **Uncontested:** 55 of 125 House districts have only one major party candidate—36 Republicans and 19 Democrats.
- **Primary election only:** 10—all Republicans.
- **General election only:** 39.
- **Both primary and general elections:** 21 House districts, of which 10 districts have Republican primaries with winners going on to the general, 6 districts have Democratic primaries with winners going on to the general, and 5 districts have Republican and Democratic primaries with winners facing each other in the general.
