Guide to the Guide for your “Day on the Hill”

This special version of **Hawver's Capitol Report's Ultimate Guide** to the 2020 Kansas Senate & House is designed for your “Day on the Hill” visit to the Kansas Legislature. It was created by **Hawver's Capitol Report**, the nonpartisan news service reporting Kansas government & politics.

To present a lot of information within a four-page section, abbreviations are used for many of the committee names, and, well, whatever else is possible.

Here are the key abbreviations:

- Phone prefixes are 296, except for a 291- for the speaker pro-tem. We're listing just the last four numbers in our Guide phone list. So, it's 296-(four digits).
- You'll notice bold face type CH, VC and RM with the names of chairs, vice-chairs and ranking minority members of each committee.

- Committee names have been abbreviated, and we hope in most cases you can infer the committee name. Those committee name abbreviations are followed by room number, days of the week of meetings.

Here is the shorthand on the abbreviations that might not be intuitive:

House

- Child/Srs is Children and Seniors
- FinInst is Financial Institutions & Pensions
- Energy, or En'rgy is Energy, Utilities & Telecommunications

- Water is Water and Environment
- Trans/Safety/Bdgt is Transportation and Public Safety Budget
- Loc Govt is Local Government
- Comm/Labor is Commerce, Labor & Economic Development
- Ag/Nat Res Budget is Agriculture and Natural Resources Budget
- Corr & Juvie is Corrections and Juvenile Justice
- SS Budget is Social Services Budget

In the Senate, it's much of the same, save for:

- Ethics/Loc Gov't is Ethics, Elections and Local Government.
