Amend the following sections of Chapter 18 Section 18.4.2(c)(ii) as follows:

18.4.2(c)(ii) Documentation that all conditions of any probation or parole term have been are being satisfied, including but not limited to any term of incarceration;

YOU ARE HEREBY NOTIFIED THAT THE FOLLOWING CHANGES IN THE RED CLIFF CODE OF LAWS IS BEING PROPOSED TO THE RED CLIFF TRIBAL COUNCIL BY THE RED CLIFF LEGAL DEPARTMENT:

PERTAINING TO CHAPTER 16 - BUSINESS LICENSE AND TAX LAW

ADDITIONS ARE INDICATED AS BOLD AND ITALICIZED

Amend section 16.10.8 to reflect additional language as follows:

16.10.8

Assessment. On January 1 of each year, the Tribe shall levy a tax on the owner of any power line or utility line equal to \$.50 multiplied by the length (in feet) of the portion(s) of the line that are subject to taxation under this section, provided that such fees may be expressly waived by the Tribe in a Right-of-Way Agreement or other agreement. After 2021, the tax shall be adjusted each year based on the cost of living increases that have occurred for Social Security Payments
