

# Protective Face Coverings

The Center for Disease Control and Prevention (CDC), the World Health Organization (WHO), and the Public Health Agency of Canada recommend the use of effective face coverings to help protect from and/or slow the spread of disease. According to the CDC, face coverings should:

- Fit snugly but comfortably against the side of the face.
- Be secured with ties or ear loops.
- Allow for breathing without restriction.
- Include multiple layers of fabric (if cloth).
- Be able to be laundered and machine dried without damage or change to shape (if cloth).
