

On November 11, 2021, from 1:00pm to 5:00pm the Dream Queen Foundation will be hosting the event at Port of Leonardtown and the adjacent park. This event will be following the Leonardtown Veterans Day parade and we are expecting upwards of 1000 guests.

We are offering the spaces to veteran owned businesses first and are not charging our veteran vendors a fee to participate. We do ask that each vendor have a quick activity for your guests to enjoy and brighten their day.

We will allow nonveteran vendors to join us at usual fees and expenses which are outlined in the contract. \$75 for the space or 10% of sales whichever is greater.

All will have to sign the contract agreement and the agreement will be customized to show veterans will not be required to pay a fee.

We will work to ensure only one business per category is represented and there is limited space.

Dream Queen Foundation is a 501©3 organization that supports The Gals Lead Teen Mentorship and Leadership training program.

Your space will be in the Leonardtown Park next to the Port of Leonardtown. Please bring your own table and tent. Tents can not be staked but anchored with sandbags or weights. Electricity is limited, we ask if you need electricity to bring a generator or personal source of power.
