I have worked in public service for most of my adult life, mainly in the area of law enforcement. I have also served in human resources which helps me understand personnel management as well as labor relations. I am also a licensed California attorney.

I believe with my background, I can bring a breadth of experience to the City Council that will serve the residents well.

My priority will always be public safety. I believe the primary duty of any government is to provide the residents with the highest quality of services to improve the quality of life, and that begins with public safety. If the residents don't feel safe in their own community, they cannot go about their lives, whether it be work or play. They cannot raise their families in peace. They cannot even go out to enjoy a simple meal if they do not feel safe.

But government needs to provide services, and those services all come from hard working people. That brings in labor relations as a key focus on keeping the best employees around to serve the residents.

Having worked extensively in both of the areas of public safety and labor relations, I believe that I use my experience and knowledge on the City Council to keep the City of Arcadia at the forefront as the premier city in the San Gabriel Valley.

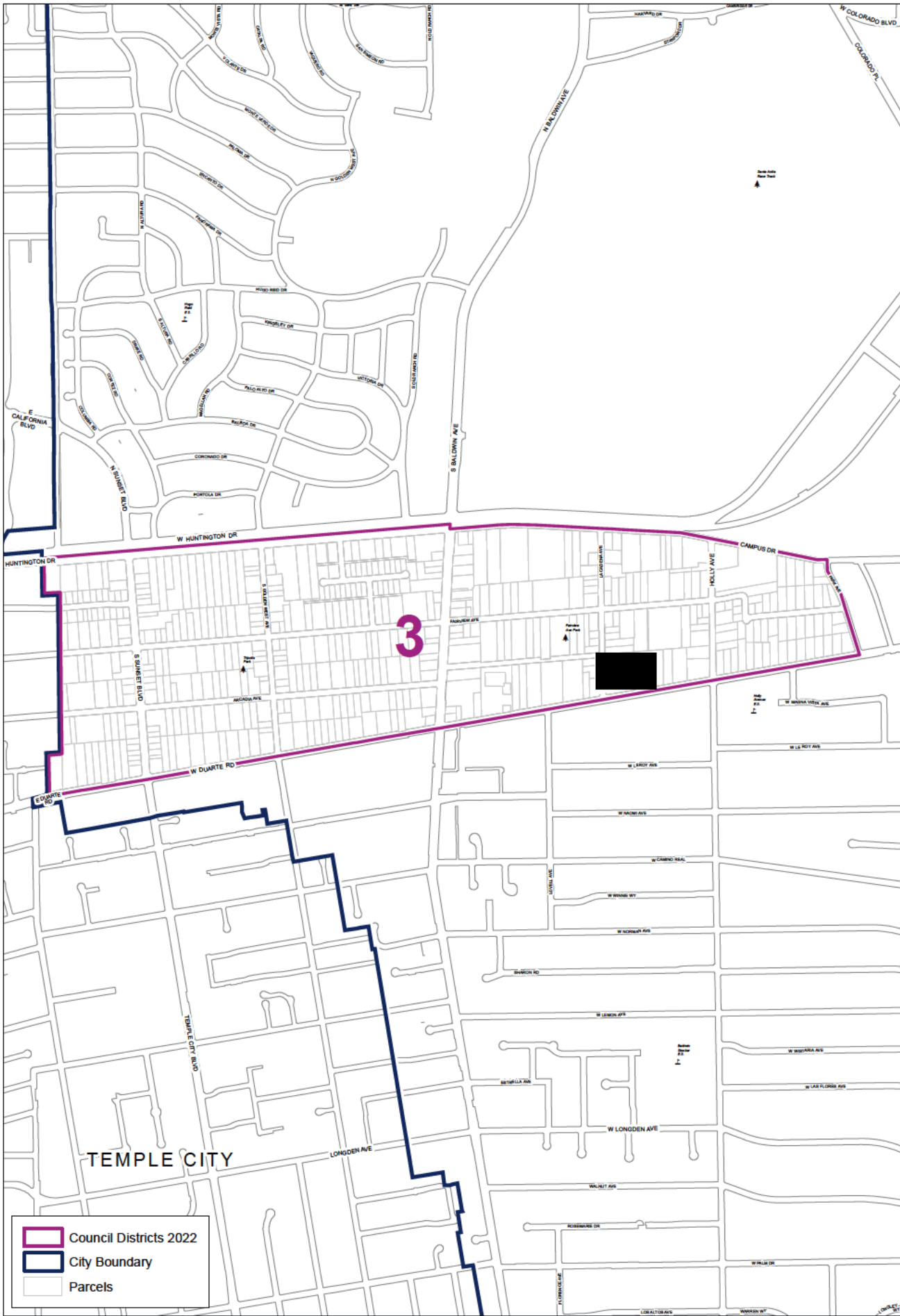
